

Waiver of Liability Form Diamond 9

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/ COVID-19

The novel coronavirus (“COVID-19”) has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people. Diamond 9 has put in place preventative measures to reduce the spread of COVID-19; however, cannot guarantee that you will not become infected with COVID-19. Further, attending any program or activity at Diamond 9 could increase your risk of contracting COVID-19.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I may experience or incur in connection with my attendance at Diamond 9 or (“Claims”). On my behalf, I hereby release, covenant not to sue, discharge, and hold harmless the Diamond 9, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of Diamond 9, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after attending any Diamond 9 program or activity.
